Covers pre wedding photos at the house and outside the Church. Church ceremony register signing, outside the Church formal shots. Continuing onto reception where we leave when the party sits down. Includes informal/candid shots during the whole day. Two photographers in attendance. Includes a viewing CD of all photographs taken. Photos up to 8" x 6"

Package 3 - £450 Attendance/Setup/Process. £10 per Photo £650 min. charge
Comprehensive package covers the whole day from bride at home until the first dance. Includes informal/candid shots during the whole day. Two photographers in attendance. Includes a viewing CD of all photographs taken. Photos > 8"x6".

- Balance of minimum charge is due 2 weeks before date of ceremony.
- A non refundable deposit of £100 is due with this form to secure the date.

Images for viewing will be placed on the web (free of charge) within 2 days of the ceremony. Special secret web address given if you wish to restrict access. Tick box if you wish to restrict access otherwise no restriction will be applied.

- Package does NOT include a wedding album. We can advise on the various types and prices if required.
- Approximately four weeks prior to the wedding a meeting will be arranged to discuss all aspects of your photographic requirements

TERMS and CONDITIONS

- The Photographer.** On occasions and without notice it may be necessary for the photographer originally specified to be substituted by another photographer. (e.g. Due to ill health or other similar circumstances)
 - Weather.** Weather permitting, the wedding photographs will be taken as agreed. In the event of adverse weather conditions, the photographers will make necessary changes in the photographic session and will not be responsible for any disappointment caused by the weather. In such circumstances the photographer with the co-operation of the client will do his best to produce coverage of the wedding within the limits of the prevailing conditions.
 - Images.** All image sizes are nominal. The photographer will provide a pleasing colour balance but cannot guarantee exact colour matching. It is sometimes impossible to record the exact colour as seen by the human eye.
 - Retouching.** The photographer will perform a standard amount of retouching to take the photographs to a quality of which he is proud. Further retouching, digital manipulation and artist finishing is available to the client as an optional extra.
 - Copyright.** Any images whether stored digitally or otherwise are protected by the Copyright and Design Act 1988. It is contrary to the Act to copy or allow to be copied photographically / electronically or by any other means an image created as part of this contract without the permission of the photographer(s) in writing.
 - Digital Files.** Digital files remain the property of the photographer(s).
 - Licence.** The photographer(s) shall be granted complete artistic licence including in relation to the poses photographed and the locations used. The photographer(s) judgement regarding the locations / poses and number of images taken shall be final.
 - Force Majeure or Act of God.** The due performance of this contract is subject to any alteration or cancellation by the photographers owing to any cause beyond their control. In the unlikely event of total photographic failure or cancellation of this contract, liability shall be limited to a refund of all monies paid. The photographer(s) are not liable for consequential loss however caused. Your statutory rights are not affected. Leisure Ireland have full Public Liability, Professional Indemnity Insurance.
 - Previews.** Although the photographer will do his best to produce more preview images than discussed with the client, there is no guarantee that any particular number of preview images will be produced.
 - Cancellation.** The client may cancel at anytime but in doing so will forfeit any monies paid. If less then 30 days before the ceremony then the client shall pay an additional amount equivalent to 50% of the minimum contract value. If less than 14 days then an amount equal to 100% of the contract value is payable.
 - Fees Payable.** All fees payable in respect of allowing the photographer to take the requested shots (e.g. In Church) are the sole responsibility of the client.
